25th Anniversary Block Party Vendor Rules

1. The location will be in the field next to Klem's in Spencer.
2. The hours of operation will be Saturday from 10:00am until 4:00pm. Vendors must arrive early to be ready to start. Set-up will begin at 9am.
3. There will be NO SELLING prior to the opening to insure proper set up for all vendors.
4. PARKING: You can park ONE vehicle in the vendor parking area during the event.
5. ELECTRICITY: There will be no electricity available. If you have a refrigerated or frozen product you must provide your own refrigeration following the MA state BOH rules on mechanical refrigeration.
6. A vendor may not leave early. Please plan accordingly and bring plenty of inventory. There is a safety issue with people trying to drive off the field when there are customers.
7. If a vendor cannot make it for any reason, please email development@secondchanceanimals.org the night before so we can adjust the set up.
8. Any violations shall subject the violator to the removal from the event.
